Contractor Safety Information

Welcome to Eagle! We are committed to the safety of all personnel on site. Before you arrive, we'd like to inform you of some basic requirements. If you have any questions, please reach out to your Eagle Mine contact, or a member of the Eagle Mine Health and Safety Team.

When You Arrive

1. Stop at our Security Gate
2. Provide Contact Information
3. Provide photo ID
4. Provide Current MSHA Training 5000.23 Documents

To inform you of site expectations, you'll participate in Contractor Hazard Training before beginning work. This should be arranged prior to arriving to the site. During this training we'll highlight our Life Saving Rules and Core Rules which give a foundational level of safety precautions and expectations.



Mobile Equipment

- Pre-operational inspection required
- Do you have pre-op forms? If not, see our Health and Safety team.
- Three basic requirements for mobile equipment include strobe light, back-up alarm and a fire extinguisher.

Fire Extinguishers

Fire Extinguishers brought on site must have current monthly and annual inspections. Be sure to inspect your extinguishers for damage and ensure gauges are in the green.



Proper Parking Requirements

- Utilize back-in parking, functional park brake applied, wheels chocked.
- Use the employee parking area unless vehicle is needed on-site.

Training Requirements

You must have current Part 48 MSHA training to work on our site. Task training records are required for all equipment to be operated

High Visibility Clothing Meeting Class II Requirements



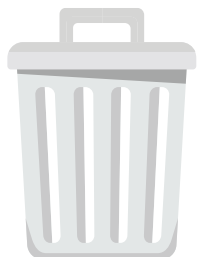
Gloves, Task Appropriate

Housekeeping

All personnel on site are responsible for keeping their work area clean. Dumpsters are provided onsite.



Approved Chemicals

All chemicals must be reported before coming to site. Chemical requests should be made two weeks prior to chemicals arriving on site. Supply an SDS for the chemical to your Eagle contact to submit this request.



Communication

It is important to be able to communicate, discuss communication options with your Eagle Contact. If using supplied handheld radios be sure to know what channels to use.

Smoking

Smoking is prohibited within 25 feet of any no smoking signage and building entrance.

Workplace Inspection

All hazards must be corrected. If it is not possible to immediately correct, barricade the area and notify your Eagle contact.

Mine Site Only

If entering the contact area, vehicles must be washed prior to leaving the contact area. Speak with our staff to fully understand the requirements.

Barricading

CAUTION

Minor Hazard (ex. hose in walkway)

Personnel may cross yellow barricade when the tag is reviewed and they are made aware of the hazard

DANGER

Significant Hazard (ex. Overhead work)

May not cross red barricade tape unless authorized by the person that installed it

Reporting Incidents

All incidents must be reported. Also, if you identify a hazard that needs corrective action or near miss please report it, these provide great learning points and drive improvement. Please see Eagle contact to report incidents.
